Dear Parent or Guardian,

Due to the continued threat of COVID-19, our Summer Playground Camp will continue to take precaution with operations this summer. This information will outline restrictions for this year's program. Safety is the number one concern for all participants and staff, therefore, we will continue to evaluate and follow state and county recommendations.

- The Playgrounds [General Wayne Park, McMoran Park, South Ardmore Park and Wynnewood Valley Park] will be staffed June 21 July 30, 2021, 9:00am–3:00pm. The playground program ends promptly at 3:00pm.
- This program is for participants ages six (6) years old and above (must have completed Kindergarten) prior to the start of the program.
- > Group size will be limited to 50 individuals, with an additional 8 staff at each location.
- Field Trips to the Belmont Hills Pool for the 2021 Season are cancelled. Campers will be able to go bowling once per week if they choose to participate.
- Participants will be required to remain with the group throughout the day. Participants will not be able to leave the playground until the end of the program.
- Facemasks will NOT be required, however, we encourage campers who are not fully vaccinated and those who might need extra precautions to wear a mask. Although people who are fully vaccinated do not need to wear masks, we will provide a supportive environment for campers and staff who choose to wear a mask.
- Participants will take frequent breaks to wash/sanitize hands throughout the day.

In case of inclement weather, the playground program will be cancelled. It is expected that you make arrangements to have your child picked up as soon as possible so the staff can be assured that your child has departed the facility.

Read and discuss the *Playground Program Rules* with your child, as well as those posted at your Playground. A violation of any of these rules may lead to disciplinary action. Be sure to sign the *Parent's Acknowledgement* portion of the *Participant Information Sheet*.

A COVID-19 Parent/Guardian Agreement form will need to be completed for each camper prior to the start of camp.

Neither the Township of Lower Merion, nor its employees are responsible for any theft or damage of property. The Township strongly encourages all valuables be left at home.

Your **Participant Information Sheet** and **COVID-19 Parent/Guardian Agreement** should be completed and handed in to the camp staff on the first day of camp.

- Additional park specific rules may be posted.

Please discourage your child from bringing personal items, such as cell phones, handheld gaming devices, MP3 players, Game Boys, iPods, toys, etc. to camp. The Township of Lower Merion Parks & Recreation will not be held responsible if an item is lost, misplaced or stolen.
